
We have heard with very great interest about the Institute of Advanced Study at Princeton. Would it be at all possible to obtain photographs of distinguished members showing their activities on the campus?

PART I. SUBMISSION OF BASIC RESEARCH GRANT PROPOSALS

GENERAL

This guide sets forth information which initiating scientists and prospective grantees may find helpful in preparing their requests for Air Force Office of Scientific Research support. Suggestions as to form and procedures have also been included, since some uniformity will facilitate consideration of proposals.

WHO MAY SUBMIT

The AFOSR considers requests for the support of basic research from non-profit institutions of higher education and non-profit organizations whose primary purpose is the conduct of scientific research. However, as a formal proposal is in most instances submitted by an organization on behalf of the Principal Investigator, research proposals normally are initiated by the scientists interested in doing the work, and if desirable may, prior to formal submission, be the subject of informal discussions between the scientists and the AFOSR scientific staff, either by letter or in person.

WHEN TO SUBMIT

Research proposals may be submitted at any time.

WHERE TO SUBMIT

Proposals should be addressed to the Air Force Office of Scientific Research, Attn: the appropriate program director, or, where the proper office is not known, Attn: SRGN.

WHAT TO SUBMIT

While no rigid form is specified, proposals should cover the points set forth below, insofar as they may be applicable. The receipt of six (6) copies of the proposal will greatly facilitate its review and evaluation.

NAME AND ADDRESS OF INSTITUTION

The name and address of the prospective grantee organization should be provided. Where the legal or corporate designation of the organization

is different from the popular or commonly used designation, the legal designation should be used.

TITLE OF PROPOSED RESEARCH

The title of the proposed research should be brief but properly descriptive.

DESIRED STARTING DATE OF THE RESEARCH

The desired starting date should be stated taking into account the several months required for review.

TIME PERIOD FOR WHICH SUPPORT IS REQUESTED

The length of time for which support is being requested should be consistent with the nature and complexity of the proposed research, up to a maximum of 5 years.

DESCRIPTION OF PROPOSED BASIC RESEARCH

An abstract, not exceeding 200 words, describing the proposed research is requested. It should be set forth on a separate page. In addition, a more detailed description of the work to be undertaken, its objectives and its relation to the present state of knowledge in the field and to comparable work in progress elsewhere, together with a bibliography of pertinent literature citations should be provided. The appraisal by the AFOSR technical staff as to the scientific merit of the proposed research will be influenced by the adequacy of this information. The AFOSR, is of course, aware that research plans cannot be spelled out in great detail in advance.

GRANTEE'S FACILITIES

Available facilities and major items of equipment especially adapted or suited to the proposed research should be mentioned.

PERSONNEL

It is expected that the Principal Investigator will be responsible for direct supervision of the work and in most instances will participate in the conduct of the research regardless of whether or not he is to receive any compensation from the grant funds.

A short biographical sketch of the Principal Investigator and a list of his principal publications should be included along with similar biographical information on other senior professional personnel who will be directly associated with the project. If applicable, the number of student or other assistants, together with information as to their level of academic attainment, should be listed. If desirable, the names and titles of other scientific and technical personnel directly associated with the project in an advisory or consulting capacity may be shown.

COST ESTIMATE

It is requested that an estimate of the total cost of the project, with a breakdown of estimated costs per year, be submitted. Parts 2 and 3 of Section XV of the Armed Services Procurement Regulation and BOB Circular A-21, provide principles for determining allowable and unallowable costs. Funds requested from the AFOSR should be indicated for each of the categories listed below. Contributions that other sources will make to the research should be listed in similar categories.

Salaries - This item should include a list of personnel; percentage of time each will devote to the research; present salary, rate of pay or stipend for each; and a total amount of salaries per year to be paid from the grant to each.

Where appropriate, funds may be requested for the purpose of defraying some portion or all of the salaries of personnel who will work on the research. The extent of such compensation from grant funds will depend on the degree to which its necessity may be justified. For research to be conducted under a grant to an educational institution, compensation at a rate comparable to monthly salaries during the academic year may be requested for work during the summer months.

When part or all of an individual's services are to be charged against a grant, it is expected that he will be relieved of a comparable portion of his teaching or other obligations.

Permanent Equipment - Itemize major items of equipment required. Title to equipment purchased with grant funds may vest in the grantee institution.

Expendable Equipment and Supplies - Indicate in general terms the types of expendable equipment and supplies that will be required.

Travel - Indicate briefly the type, frequency, and applicability of travel to the research.

Publication Costs - Indicate briefly any types of publication costs anticipated, including the purchase of reprints.

Other Direct Costs - Itemize other anticipated direct costs not included above.

Indirect Costs - Suggest a rate for allowable indirect costs based on the principles set forth in Parts 2 or 3, as appropriate, of Section XV of the Armed Services Procurement Regulation, taking into account previous research-contract experience where relevant. If the grant funds requested are to defray indirect costs, as well as direct costs, this rate will be subject to further discussion with AFOSR representatives before the grant is made. An established rate may be revised for subsequent grants at the request of the grantee or grantor. Institutions not having information on which to base a suggested indirect-cost rate may request determination of such a rate at the time the proposal is submitted.

Total - Give totals of all costs by years and a grant total as well.

OTHER SPONSORS

State whether (and if so, to whom) the proposal has been submitted to other possible sponsors, including other Federal agencies, and state proposed total cost to other sponsors. Indicate also any present sponsors of any portion of the program outlined in the proposal. The submission of a proposal to other organizations concurrently with its submission to the AFOSR will not prejudice its review by the AFOSR but notification of other sponsorship is requested. This information, together with data exchanged regularly among Federal agencies sponsoring basic research, contributes materially to planning for the optimum distribution of Federal funds available for the support of scientific research.

APPROVAL

One copy of the proposal should be signed by the Principal Investigator, by the department head, and by an official authorized to sign for the institution. All copies of the proposal should indicate persons, with titles, who have signed the original of the proposal.

REQUESTS FOR CONTINUED SUPPORT

The AFOSR will consider requests for continued support in equal competition with all other proposals pending in the AFOSR at the time of such request. Consequently, these requests should contain the same information as any other proposal in addition to a resumé of progress to date. The same amount of time for review and evaluation will be required and such requests should be submitted at least 6 months in advance of the anticipated termination date of the original grant if the Investigator and the institution are desirous of uninterrupted support.

PART II. ADMINISTRATION OF BASIC RESEARCH GRANTS

GENERAL

The AFOSR assumes that, once a grant is made, the Principal Investigator, operating within the policies of the grantee institution, is in the best position to determine the means by which the research may be conducted most effectively. Accordingly, the primary responsibility for the administration of any grant is one that is shared by the grantee and the Principal Investigator. The AFOSR wishes to avoid any action which might diminish the responsibility of the grantee and the Investigator for making sound scientific and administrative judgments. Grantees and Investigators are encouraged to seek the advice and opinions of the AFOSR Contracting Officer and Project Office(r) on problems that may arise. Unless otherwise stated, the giving of such advice should not imply that the responsibility for final decisions has shifted to the AFOSR. The primary concern of the AFOSR is that granted funds be used in a manner which will make a maximum contribution to the progress of science - and it is expected that grantees and Investigators will also direct their efforts to this end.

GRANT AGREEMENT

An AFOSR grant is consummated by an agreement signed by an AFOSR Contracting Officer and the grantee. Normally, this agreement will contain a minimum of express conditions which upon acceptance of the grant will bind the grantee. These conditions may relate to the general nature and scope of the research, revocation of the grant, and patent rights. The simplicity of the grant does not preclude the possibility of collateral understandings and informal agreements which may, in special instances, accompany the formal grant or accumulate, as the occasion demands, during the life of the grant.

The grant will be addressed to the business office of the institution to which the grant is made.

GRANT PERIOD

Normally, AFOSR grants are made for periods up to five years. As stated in the grant instrument, the period is approximate; beginning and ending dates are not specified. The grant period begins approximately on the date of the grant and extends for approximately the length of time specified. However, when progress of research under the grant is delayed and circumstances make it necessary to request an extension of the grant period without additional funds, it is the policy of the AFOSR to permit extensions in time, upon written request.

Where it appears that the research contemplated will be completed within a reasonably short period of time after the approximate ending date, it will not be necessary to request an extension. However, if it appears that the time required will exceed 4 to 6 months, it is requested that the Contracting Officer be informed and an extension requested.

GRANT PAYMENTS

Payments will be made in advance in a lump sum payment or on a periodic basis, depending on the relative size of the total grant and the estimated timing of financial requirements. If payments are to be made on a periodic basis, the schedule of payments will be set forth in the grant instrument. No vouchers for payment need be submitted by the grantee inasmuch as payments will be made automatically by an AFOSR designated Air Force Finance Office in accordance with the payment schedule.

If, during the life of the grant, fiscal reports indicate that the actual rate of expenditure will deviate markedly from the estimated rate, the AFOSR may consider it desirable to reschedule the remaining payments. In this event, the opinion of the grantee and the Principal Investigator will be sought regarding the contemplated adjustment, and if mutually agreeable, a change in the schedule will be made. Conversely, the AFOSR will at any time be glad to consider a request initiated by the grantee or the Principal Investigator for a revised schedule.

ADHERENCE TO ORIGINAL BUDGET ESTIMATES

The AFOSR believes that the Principal Investigator, operating within the established policies of the grantee institution, is the individual best qualified to determine the manner in which the grant funds may be used most effectively to accomplish the proposed research. Therefore, once the grant has been made, the Investigator and the institution are free to spend the funds for the proposed research without strict adherence to the original budget estimates. However, the AFOSR will appreciate being kept informed of contemplated major deviations from the budget estimates and the reasons therefor.

ASTIA SERVICES AND DOCUMENTS

The Armed Services Technical Information Agency (ASTIA) provides a central service within the Department of Defense for the controlled and timely interchange of scientific and technical information. It is responsible for collecting, indexing, cataloging, abstracting, and storing scientific and technical reports, and distributing these reports to authorized persons or organizations upon request on a no-charge basis. The ASTIA services and documents may be provided to the grantee upon request to the Contracting Officer.

EQUIPMENT

Normally, the grantee institution will retain title to any equipment purchased with grant funds.

SECURITY

As a general rule, grantee personnel will not need access to classified security information in the conduct of basic research supported by the AFOSR. In exceptional cases where it appears that access is desirable the grantee shall request clearance from the Contracting Officer. When in the judgment of the Principal Investigator, information is developed that should be classified, he shall notify the Contracting Officer immediately.

PATENTS

Disposition of patent and other rights in any inventions or discoveries made or conceived during the research shall be the responsibility of the grantee; the grantee shall give the Contracting Officer reasonable notice of an application by the grantee or other person or institution for a foreign or domestic patent on any such invention or discovery; and upon issue of any patent on any such invention or discovery, the patentee shall grant the Government an irrevocable, royalty-free, nonexclusive license for use of such invention or discovery for Governmental purposes. As to any invention on which the grantee elects not to file a patent application, the grantee shall give to the Government the right to file a patent application and convey to the Government sole and exclusive title in the invention.

At the conclusion of the work under the grant, the grantee will furnish to AFOSR, Attn: RRJ a report listing all inventions conceived or reduced to practice in the course of the research and indicating whether the grantee intends to file a patent application with respect to each such invention. If there was no invention, a statement to that effect is requested. For the grantee's convenience, Section I of DD Form 882 may be used to accomplish this report.

FISCAL REPORTS

Interim fiscal reports are required annually, for each grant, in addition to a final fiscal report. Report forms for this purpose are forwarded to the business office of the grantee institution, together with the copy of the grant instrument. Additional forms may be requested. The final fiscal report is to be forwarded to the Contracting Officer after work under the grant has been completed.

PUBLICATIONS

It is assumed that the principal product of the research will be papers published in scientific or engineering journals. Normally, reprints of these articles will serve the needs of AFOSR for formal reports of research results. Six reprints of each publication should be sent to AFOSR as soon as they become available, even after termination of the grant. The grantee is requested as a matter of information to submit to AFOSR (Attn: Office symbol of the initiator named in the grant), a copy of each paper planned for publication at the time it is submitted to a journal. AFOSR would also appreciate being informed of any results of unusual interest when they occur.

A comprehensive report (5 copies) will be submitted at the expiration or revocation of the grant. The final report should contain a chronological bibliography of all publications resulting from work aided by the grant. Whenever appropriate, reference may be made to reprints in lieu of reviewing the same work in the final report.

AFOSR TECHNICAL REPORTS

In addition to publication in scientific journals, the grantee may, under unusual circumstances, wish to prepare a special report of greater length or scope than is normally publishable in the scientific literature. Such a report must be authorized by the Executive Director of AFOSR to be published as an AFOSR technical report. These reports are to be reproduced (not to exceed 100 copies) and distributed by the grantee according to mutual agreement with the initiator in the scientific directorate.

ACKNOWLEDGMENT

Publications based on work aided by AFOSR should be acknowledged essentially as follows: "The study was supported by the Air Force Office of Scientific Research."

REVOCATION OF GRANTS

An AFOSR grant may be revoked in whole or in part after consultation and agreement with the Principal Investigator and the grantee, except that a revocation shall not affect any financial commitment, which in the judgment of the contracting officer and the grantee, had become firm prior to the effective date of the revocation; provided, however, that the grantee shall reduce, insofar as is possible, the amount of outstanding commitments. Grantee shall repay to the AFOSR by check made payable to the Treasurer of the United States, the uncommitted balance of all funds which shall have been paid to the grantee by the AFOSR under the terms of the particular grant concerned.

The grantee shall communicate with the contracting officer whenever, in the opinion of the grantee, there is reason to believe that circumstances may necessitate revocation. It is expected that the most common cause for revocation will be the inability of the grantee to carry out the research for which the grant is made, or to adhere to the other conditions set forth in the grant instrument. As a general rule, the availability of the services of the Principal Investigator named in the grant instrument is one of the conditions of the grant. Consequently, the contracting officer must be informed immediately whenever it appears that the Principal Investigator will find it impossible to continue to direct the research.

TRANSFER OF GRANTS TO OTHER INSTITUTIONS

When the Principal Investigator changes his organizational affiliation and desires support for his research at his new location, he must submit a new proposal via the appropriate officials of the new institution. Although such proposals will be reviewed in the normal manner every effort will be made to expedite a decision. Regardless of the action taken on the new proposal, final reports on the original grant, describing scientific progress and expenditure to date, are required.

GRANTS FOR CONTINUED SUPPORT

When a proposal requesting continued support for research previously supported by the AFOSR is approved, a new grant will be issued. Although special arrangements for voiding the requirement for a final technical report on the first grant may be made, it will be necessary for the grantee to submit a final fiscal report. Normally, if the funds for the second grant are received prior to the time that funds from the first grant are exhausted, work under the first grant should be considered completed on the day when funds are fully expended or committed. Likewise, work under the second grant should be considered as beginning on the day following. New accounts should be established for the second grant in order that the recording and reporting of expenditures may be segregated.

ACCOUNTING PROCEDURES AND AUDIT

While no particular classification of accounts is required, it is expected that grantees will maintain records for each grant, in accordance with generally accepted accounting practices, that will permit preparation of the required fiscal reports and make possible the determination that grant funds were used for the purpose for which the grant was made.

Dear Dr. Oppenheimer:

We're looking at a table in the 1955 World Almanac. The 1952 total enrollment in all types of higher educational institutions is given as 2,148,284. For 1953 (last year listed by the Almanac) it had grown to 2,250,701. The difference of 102,417 students represents a 4.8% rate of growth.

A continued growth at even a small rate percentagewise can achieve phenomenal results over a period of several years. If the 4.8% rate of growth remains constant, by the end of 1955 the total enrollment in higher educational institutions should have increased to 2,472,700. But wait a minute! We're already out of date.

According to Economist Peter F. Drucker, writing in the March, 1955, issue of Harper's Magazine, the number of full-time and part-time college students had increased to an all-time high of 2,500,000 in 1954. Our calculations above are just a year behind times.

Let's resist the temptation to use the 10% rate of growth that actually occurred between 1953 and 1954. When we peer further into the future, we'll be ultraconservative. The time is now 1960, and we are assuming that the rate of growth in college enrollment has been only 4.8%. Starting with the 2,500,000 enrollment of 1955, every year has been 104.8% of the year preceding. What will 1960 total enrollment be?

As we figure it, the 1961 World Almanac will have to list a 1960 enrollment of 3,160,400 in higher educational institutions. That's 660,400 more students than were enrolled in the record-smashing year of 1954. Somehow and somewhere, places will have to be found for them.

The pyramiding may be expected to continue for the years to come. Drucker forecasts 1975 college enrollment of 9,000,000 to 12,000,000 -- about four times present enrollment. New classrooms and dormitories certainly will have to be constructed.

Dear Captain Alberto:

It was good to have your kind letter. I am most interested in the possibility of welcoming students from your country to work here at the Institute. In fact, just such things should be one way in which the Institute can be most useful in the next year or so.

As you no doubt know, the Institute for Advanced Study is not a universal school, and offers work only on a rather high level, and only in restricted fields. The fields in which we have some competence are mathematics, theoretical physics, computing, fiscal studies, military history, theoretical economics, and certain humanistic studies, particularly in Hellenistic culture.

It has been our practice to admit as students only men and women who have their Doctor's degree or, in rare circumstances, men and women of equivalent academic training. In fact, we have no adequate provision for the instruction of less completely trained students, and almost never give formal courses of instruction.

It would be desirable that any candidates from Brazil who might find a year here profitable should apply directly, giving a notion of their previous training and their field of interest, and the work that they would propose to do while in residence here. There are a number of formalities which must be seen to before a membership can be granted, but you can be quite sure that I shall do my best to see that all qualified candidates from Brazil are given the most sympathetic and cordial consideration, and that applies not only to those who would work directly with me, but to all others.

The Institute is in a position to grant memberships both with and without stipends. Since competition for the former is somewhat more extreme, it would be an advantage to your candidates if they could be supported by grants from their own government, or by grants from the Rockefeller Foundation during their studies here. But, equally, this is by no means necessary if they are qualified and their interests lie in fields where we can be of genuine service to them.

You may be sure that I have followed with great interest and frequent admiration your own work in UNAEC. I have a sense of gratitude to all of you who, despite discouragement, have continued to work for a noble solution of these problems.

Though having been first to renew our correspondence, to which I beg to stick very closely indeed (I wrote you on January 5th) I still appreciate and welcome very heartily indeed your very kind letter of March 2, 1945, which I am just opening today. The letter is a most kind and most obliging one. I am feeling your warm shake-hands and am doing the reciprocal gesture.

The package of books will be received with deeply felt thanks and forwarded to the Institute of Oriental Studies. As to that one which has myself as its addressee, my words come to their end, as I am really too moved in heart to express exactly my gratitude. Anything I can do by way of books in Russian or through my written contributions in English I will do with enthusiastic promptitude.

After having spent about three years in Kazakhstan where I had been evacuated through the government act of privilege to work far from besieged Leningrad, that act having given the best results imaginable as I wrote in my seclusion quite a lot of useful things, I am at last here.






