I do not know how to respond to your request for comments on the proposed paragraph 15. In the first place, I do not feel able to respond as a member of the Faculty Advisory Committee, since the School of Mathematics has at least temporarily withdrawn its representation on that committee. (See Borel's letter to you a few weeks ago.)

However, speaking only for myself, the proposed paragraph does seem quite constructive, provided that it is intended as a draft of a statement by the Board of Trustees. I believe that such a statement, formally guaranteed by the Board of Trustees would be welcomed by many Faculty members.

As a statement by the Faculty, it does not seem to make much sense, and in any case I do not think that you will be able to arouse any enthusiasm among the Faculty for amending or otherwise altering the late lamented "Responsibilities of the Faculty in the Governance of the Institute." This document was valuable as a declaration by the Faculty of its ideas as to how the academic business of the Institute ought to be run; but it was given force only by your promise to abide by its procedures. Since that promise has been withdrawn, it hardly seems worth tinkering with the document at this date.
