Dear Mrs. Pitzele:

I am sorry that a whole week has passed since the service for Professor Lowe without my being in touch with you, but these have been busy days at the office. I have, nonetheless, taken the time to call Central Jersey Sound to indicate the embarrassment (to both you and me) as well as the confusion caused by the late arrival of the technician with his equipment. It was an unfortunate situation, and I felt particularly disturbed because I had taken the trouble to call that very morning to confirm the need for being here between 12:30 and 1:00 and allowing for the difficulty in finding the Institute. Mr. Ducore tells me that his man did in fact leave in time to arrive here at 12:30 but somewhere he made an illegal turn, was stopped by a policeman and given a ticket; then in his distress he made a wrong turn in following the directions to the Institute and thus was further delayed. I think there was some amount of irresponsibility on Mr. Ducore's part for not having checked out the Institute's location during the weeks in which he had this assignment on his books, and I told him this. He reiterated that he was indeed sorry for what had happened but could see nothing he could do at this point to remedy the matter - true, of course. However, perhaps it would not be out of order for you to suggest, if you order copies of the tape, that he make them available to you at only the cost of the tapes since he really owes you some time! I now have his bill for \$100, the price he had quoted. Since the Institute is tax exempt, shall we pay the bills and submit the total to you then for reimbursement? I have no bill from either the florist or the caterer yet and no idea what they will be. The Institute has assumed the cost of the invitations.

We felt the flower arrangement should go to someone appropriate and, therefore, offered it to Dr. John. I am afraid Virginia Brown is the one who was so busy helping both before, during and after the service that she had little, if any, opportunity to participate as a guest; but, of course, things would never have gone so well without her, and she enjoyed being useful. I hope you and the other members of Professor Lowe's family felt that the service accomplished what you had in mind. I was sorry not to be able to be there throughout; I am sure it meant a great deal to you all to have so very many people come and, in many cases, from great distance.

Dear Dr. Kaysen:

I told you at the time we spoke together at the Institute in August, that I would suggest a date for the memorial service now planned for my father, Dr. E. A. I.we. He would have been ninety on October 15, that magic day he was so hoping to reach. but my sister, Mrs. James Fawcett of London, cannot arrive until early on October 16. How would that day be? Perhaps in the early afternoon? As alternatives, I would suggest the 17th or 18th, though Saturday may be a bad day for most people. Mrs. Fawcett would not be able to be here on October 21 or 22, but the 23rd, 24th or 25th would be all right for her.

Your suggestions as to possible speakers I concur with heartily: Frederick Atams, Professors Merritt, Claggett, and was it Morse? and my own suggestion of Meyer Schapiro, who worked with my father closely over the years. I do not know if it would be out of place, for me to suggest also Prof. Don Wolfe? I know only that he and Mrs. Wolfe were deeply devoted to him, and he to them, and they were so very good to him. The Ode to the Nightingale was whe of my father's favorites. Perhaps Don Wolfe - or anyone else - might read it? On personal terms, I feel that too many speakers might become repetitious, and if the above number seems too many to you and should therefore be shortened, I would include: Messrs. Schapiro, Adams, Wolfe, Morse, Claggett, and Merritt, in that order of preference. However, I do not feel strongly about this in any way, and would boy to whatever judgement you had on the subject.

Dear Dr. Kaysen:

Apparently, my father, Dr. E. A. Lowe, appointed no literary executor. Therefore I, as executrix of his estate, am sending you as director of the Institute, this letter expressing the hope of his family that his work in progress will see completion.

There seem to me to be two elements involved in the winding up of CLA, both the Supplement and the Companion volumes, as well as the reisage of Vol.II, the publication of Handwiting, and the volume of collected shorter papers.

First, that all of Dr. Lowe's books, manuscripts, files, papers, and notes, remain in one place, ideally the place where they are now, namely at the Institute. I was most grateful to learn from you that the Institute wishes to retain intact the scriptorium, as he called it, until the end of the academic year now commencing, and I am writing to the Morgan Library asking them not to take possession of that part of my father's library already sold to them until this work is finished.

Second, that these familiar with his work remain with it until its completion. My family feels more than fortunate that James John is to be at the Institute this year to work on and oversee the finishing of the final, companion volume of indexes to CLA, and perhaps my father's hoped-for "preface of prefaces." Having heard my father express himself many times on Virginia Brown's extraordinary competance, we are doubly fortunate that she too will remain to finish up the work. She has told me, however, that there is some doubt about the second semester. I very much hope it will be made possible for her not only to see the works through to the end, but also to help me in the necessary cataloguing and disposing of whatever there is, not automatically destined for the Morgan Library. If provision for her work during the second semester makes a problem for the Institute, possibly my father's estate can make some sort of financial arrangement with her, so that what time she has available can be spent on these matters.

I expect to be in Princeton during the day of Wednesday, Sepember 3, and starting Wednesday of the following week, all the time until the house is emptied of my father's possessions. Should you wish to reach me, Mrs. John, Mrs. Wolfe, or Virginia Brown, will surely know where I am.

Thank you very much indeed for your kindness and great consideration to my father. My sister and I in particular have appreachated this deeply.

Dear Mr. Adams:

I have recently talked to Dr. Carl Kaysen, of the Institute for Advanced Study, and it is his plan to retain the scriptorium of my father, Dr. E. A. Lowe, through the academic year now beginning, so that the work in progress at the time of his death can see completion.

Clearly, this would be difficult if the Mergan Library new decides to take pessession of the books and other materials in his library that it ewns. And so I am writing to request that this be postponed until next spring.

There is nothing Dr. Lewe's family more ardently wish than that his work, that consuming passion of his life, be brought to its intended conddusion. So perfectly had he planned it, that other hands trained by him can carry out this conclusion - with the possible exception of what he liked to call his "preface of prefaces, to accompany the companion, index volume, the final volume of his life work Codices Latinae Antiquiores. The other works, all I believe in proof, are CLA Supplement, Handwriting, the reissue of CLA Vol. II, and the collected shorter works.

We are more than fortunate that James John was already retained to work at this Institute this year, to oversee the completion of the Companion, and that Virgina Brown, whom my father believed extraordinaryly capable, is also there to finish the rest and to deal with all loose ends still to be tied.

If the Morgan Library sees fit to leave my father's library where it is until the end of the academic year, perhaps you will be kind enough to write Dr. Kaysen to this effect.

I sincerely hope that you will be back in town at the time of the planned memorial to my father, to be held in Princeton some time after October 15 - his 90th birthday. Dr. Kaysen thought maybe you would be willing to say a few words, and I would like to add my hope to this end.
