Referring to our earlier correspondence, and particularly to my letter of June 27, 1950, to Dr. Oppenheimer, and your reply of July 10, 1950, you will recall that there was a question of an additional appropriation of \$300.00 to bring the total contribution of the Institute to the Herzfeld Memorial Volume to \$1800.00. At that time I expressed the hope that I would not have to ask for this extra sum which Dr. Oppenheimer kindly said he would try to find if needed. But as so often happens actual costs of production have far exceeded original estimates, and the publisher and printer (J.J.Augustin), in spite of taking all the income that may be anticipated from sales, is probably going to lose substantially on the undertaking. He is, however, willingly absorbing this loss because of his regard for Herzfeld, for whom his firm printed some of Herzfeld's works during the latter's lifetime. I might say that the fact that costs are exceeding the original estimates is entirely my own responsibility in that, under pressure that I should have resisted, I have permitted contributors to the volume to run over their quota of words and illustrative material. The result, of course, is a more valuable volume, but also a more expensive one.

In order that I may at least meet Augustin's original estimate of \$1800.00 I must therefore ask if is now possible for Dr. Oppenheimer to find the additional \$300.00 referred to in your letter of July 10, 1951. If so, I shall needless to say be most grateful. And if the sum is available I would like to have it, as well as the balance of \$200.00 from the original appropriation, now, as Augustin is preparing to go to press in January. Dear Dr. Oppenheimer,

I believe that Dr. Richard Ettinghausen wrote to you on January 30th of this year to the effect that he had asked me to take on the editorship of the proposed Herzfeld memorial volume. I believe he also informed you that tentative arrangements had been made for the publication of the volume by the Ascona firm in Switzerland. Since I assumed responsibility for the editorship I have been concerned over rumors to the effect that the Baron von der Heydt of Ascona, who had undertaken through the Ascona firm to advance half of the necessary funds, had been under some suspicion of having aided the Nazis in the last war. While the Department of Justice declares that it cannot inform me explicitly of its reasons for blocking the Baron's funds in this country, the final disposition of the case not having been determined, I have sufficient confirmation of the existence of these suspicions from another reliable source so that I have decided, and Dr. Ettinghausen concurs, that it would be improper to bring out the Herzfeld volume under this patronage.

While I do not wish to trouble you with these details, I feel it proper that you should be advised of this decision. I am now negotiating with another firm, that of J.J. Augustin & Co., who have submitted a tentative estimate of \$1800.00 for the production of the volume. With the \$1500.00 which you have undertaken to furnish toward the project I may hope to be able to finance the deficit by an arrangement with Augustin providing for his receipt of entire profits from sales, if any. If, however, you were able to guarantee the \$300.00 in case Augustin were unsuccessful in covering his costs and profit, it would obviously be a great help and assurance to me. Would you be good enough to let me know whether there is any possibility of this.

We therefore had to give up this project.
