"Mrs. Fuld and I have taken the closest interest and the most profound pleasure in our association with this enterprise. We feel, however, that we wish in its interest not to be burdened with responsibility but rather to leave responsibility in the hands of the Director and the Trustees. We have discussed this matter fully with the Director, and it is our opinion, in which he concurs, that the By-Laws can be simplified so as to permit a gradual evolution by dropping the offices of President and Vice-President of the Board of Trustees, so that the executive management of the Institute will remain in the hands of the Trustees while the Director will be responsible for the scientific direction. I trust that this informal notice on our part will be accepted by the Board and that suitable amendments and nominations may be submitted at the annual meeting of the Board. I assure you that my interest and Mrs. Fuld's interest have become keener and keener as time has passed and that we will do all in our power to promote the objects for which the Institute was founded.

"I beg you to accept our warm thanks for your invaluable cooperation and support, and we look to you to maintain the high standard at which a beginning is now to be made."

He is writing on a delicate matter. He understands that Strauss has been approached about becoming Chairman of the Board if and when Maass withdrew. This was before his appointment to the Atomic Energy Commission. He indicated that he would take over when Maass withdrew. There is a fairly strong sentiment in the Board that so long as he is devoting himself to the Atomic Energy Commission, it would be unfair to him and the Institute if he took the responsibility of Chairman. > next few years will be very critical for the Institute. We should have a Chairman who can be readily at hand and give the time and energy needed. "Until you took over, things were handled in a very autocratic fashion. Now it has become possible to have discussion and we always feel free to turn to you when we have something on our mind. I would not have dared, for example, to write a letter of this sort to your predecessor."

Another reason why Strauss might deferer the chairmanship is that he is a newcomer. Weed has been with the Board a long time, since its beginning. "He would make a forceful chairman who would have three years to go before his retirement at ix sixty-five." Probably everybody on the Board and Oppenheimer also, would appreciate Weed's chairmanship, everybody except Aydelotte.

"One thing we did not foresee is that Oppenheimer is a very close personal friend of Felix Frankfurter and as soon as Oppenheimer approached him, Frankfurter let down his hair and brought up all the tribulation which he once had with the Institute. yet been informed of the action of our committee, but reacted quickly, told Oppenheimer that the Frankfurter episode was a thing of the past, that the Institute Trustees were a forward-looking group, that they would work with him in the fullest cooperation, and that this would be tax true whoever was appointed as Chairman of the Board. I think there would be some doubt in Oppenheimer's mind as to whether Strauss would have the time to give to it, but I don't believe that he would feel concerned on any other ground. They evidently saw a good deal of one another's work during the war and there is a strong feeling of mutual admiration.

"Weed is unaware that I am raising the question of Strauss' chairmanship and I have discussed the matter with no one save Lewis, who told me several days ago about his conversation with Oppenheimer and about the Frankfurter episode."

"Now with respect to the subject matter of your letter, I shall, of course, accept it in complete confidence. It is only by a complete exchange of views that all of us who are so interested in the future of the Institute can bring about what is best for it. Of course. I have no knowledge of what the nominating committee may contemplate in respect of the appointments to the various offices and were they to suggest Strauss for an important office. I doubt whether he would consider accepting it at this time in view of his present preoccupation with the affairs of the Atomic Energy Commission. Certainly, unless he were able to give all the time required of the job. his appointment would be most inexpedient. Personally, I have felt for a long time that as I occupied both the office of Chairman of the Board and President of the Institute it would be beneficial were the Committee to nominate a new president and permit me to remain as Chairman of the Board, for I think such a change would fortify the management and operation of Institute affairs. No one has a greater admiration for Weed than I havd and I think his nomination to either office would tend greatly to benefit the Institute.

> "I did hear some remote suggestion that Dr. Avdelotte had intimated a desire to be named Chairman of the Board, but such an appointment, I think, would be most inappropriate and tend to complicate the administration of affairs. At this great distance, and particularly since I am out of touch with the whole situation, it is impossible for me to take a firm attitude in respect of the matters to which your letter refers, but I have herein outlined my general views which I hope largely accord with your own."

He then asks for information as to what is happening on the Oppenheimer appointment.

Comments on his surprise at the recommendation of the Committee to re-elect Maass for five years. "This must have been a move to keep Strauss from taking over at a time when he is completely preoccupied; but the vote puts both the Trustees and Maass himself in a very awkward position..." Here he alludes to pushing Aydelotte out on the basis of age and re-electing a 70 year old Chairman. It might have been better to give Maass a one-year appointment as Chairman, but a five-year appointment seems entire/inconsistent. (Aren't the

officers elected annually? -- My observation).

Fulton notes there is barely a quorum, and that the vote ought to be re-phrased. Maass, apparently, expressed freely embarrassment at the time of the meeting.

"Having said all of this, let me reiterate that I personally should much prefer Maass to Strauss."

"I was fascinated by John Hancock. Although I probably should not say this, it is nice to have in our midst a good Anglo-Saxon who knows something about investment banking."

Lewis to Fulton, April 22, 1948.

The first I heard of Maass' reappointment was when it was proposed. The Nominating Committee knew nothing whatever about it. "As I recall it, we were both appointed tothis Committee." He suggests this is no time for a rumpus, let's take it up quietly with Oppenheimer. Oppenheimer is doing a superb job.

He has sent a copy of both of these letters to Weed.

He said, "The whole thing seems to me even more fantastic if there had never been a meeting of the Nominating Committee. A copy of the statement of Strauss, June \$1, 9, 1949, on his testimony June 8, 1949, before the Joint Committee of the Congress of the Atomic Energy Commission. In this statement Strauss discloses the events in a meeting of the Atomic Energy Commission at which he was the sole dissentor to send radio active isotobes to foreign countries, and he does a terrific job in this statement.

> Strauss sends the mimeographed copy of the statement to Fulton. Fulton replies to Strauss, July 18, 1949.

> "I am very glad to have it because many of your friends were profoundly disturbed will by the fact that you testified first, against your chairman and later, against Robert Oppenheimer for whom I had assumed you had a high regard scientifically.

"The summary of your testimony makes your position clear, but I am not satisfied that as a manuscientify non-scientist you are in a position to take issue with Robert Oppenheimer whose background in these things places him a position to speak with authority.

"In the circumstances, I assume that you propose to withdraw from the Atomic Energy Commission and I would suppose, also, from the Board of Trustees of the Institute for Advanced Study."

Fulton sends a copy of his letter to Strauss to Maass.

> Maass to Fulton, Jul y 22, 1949, taking violent exception to Fulton's position, and saying that the matter is not so much scientific as it is legal. Nor does he believe that in the execution of a man's duties he must resign if he differs with his colleagues.

"In so far as any difference in point of view between Lewis Strauss, member of the Atomic Energy Commission, and Robert Oppenheimer, citizen, (not Director of the Institute for Advanced Study) may go, this certainly does not affect the relationship of either of them to the Institute. As I reflect upon the matter, I am inclined to believe that your letter must have been written in haste and that while it may express your personal view, it should not have contained your suggestion regarding the resignation of Lewis Strauss as President of the Institute, unless you had reason to feel that a majority of the Board of Trustees concur in your attitude. I, for one, would certainly not do so, and I doubt, if the whole matter were laid before the Board, that many or perhaps any of the other Trustees would concur with you. ~ Beatrice Stern Research Files: Topical Card Files: Box 4: Officers

"The thing that has upset so many of Strauss' one-time friends is that he should have chosen to attack David Lilienthal in a public hearing at a time when Mr. Lilienthal was under outrageous attack by that scurvy fellow, Hickenlooper.

"...the issue involved was not a legal one but a question requiring mature judgment of an experienced scientists. Lewis Strauss elected to pontificate in a field × that was not his own, and it has left an extremely sour taste in the minds of those who know the facts.


