

Dear Whitney:

I do not quite know how to answer your letter of December 15th because the only letter which I can remember having spoken about was the one to tell you about the opportunities in biology for Mrs. Whitney.

As I recall it, the outcome of our conversation was that I said that in case you signified your intention of accepting such an offer, I would recommend to Dr. Flexner that you should be appointed to a position in the Institute for one or two years at a salary of \$2700. a year. I explained that the academic year of the Institute runs from the first of October to the first of May with a vacation of about a month at Christmas time. The duties would be such as you are already acquainted with as a National Research Fellow. There will be an opportunity for you to give a course of lectures or a Seminar if you wish and I would also welcome your cooperation in my Seminar.

As I understand it, the Institute is not trying to pull young men away from universities by offering them superior financial inducements. The salary which is proposed was therefore arrived at so as not to represent a decrease from what you are already getting and not to be high enough to require much stepping down if and when you leave this position for a regular academic one.

While I feel that you are being offered a very unusual opportunity to be associated with the group of mathematicans who will next year share in the work of the Institute, I do not wish to urge my advice in opposition to what you may receive from your former teachers at Harvard.
