Dear Professor Speziali:

I hope that my letter of June 24 has meanwhile reached you.

In a letter to Miss Dukas of October 23, 1970 you advised her that you had recently a visit from Professor Jagdish Mohra from the University of Texas in Austin. I should like to ask a few additional questions in regard to Professor Mehra's visit. In a volume entitled EINSTRIN by Ronald W. Clark, which has just been published in the United States, it is mentioned (page 634) that Dr. Mehra possesses, copies of Einstein's correspondence with Michelangelo Besso. Unless I misunderstood your letter of October 23, 1970 to Miss Dukas you had only allowed Mr. Mehra to read Einstein's letters. Under the circumstances would you be able to suggest how Professor Mehra can claim to possess copies of those letters? For reasons which we do not like to set forth in a letter we should be very enxious to throw as much light on Professor Mehra's claim as at all possible. In the letter which you said he sent to Mr. Vero Besso, did he explain at all why he would want to acquaint himself with the Einstein Besso correspondence?

We should be very grateful for anything you could tell us about that matter. I am sure you have by now been able to send the final manuscript of the correspondence to Paris. I can well imagine that you will feel a great satisfaction when your work is actually sent to the printer and when it will in due time appear as a printed volume.

Je vous remercie vivement de vos lettres du 24 juin et du 2 juillet (le service postal est actuellement quelque peu irrégulier). Il y a deux points de la seconde auxquels je tiens à répondre : le Dès que je n'aurai plus besoin pour mes vérifications des lettres de Besso à Einstein, je les remettrai à Mr Vero Besso de votre part et de la part de Mlle Dukas. Je suis certain qu'il les acceptera avec joie et gratitude ; 2º J'ai parlé dernièrement encore à Mr Vero Besso des lettres d'Einstein à sa soeur. Il est naturellement d'accord pour vous en transmettre la copie je ne crois pas nécessaire que vous lui écriviez - seulement, il m'a demandé de m'en occuper et je ne pourrai le faire qu'à mon retour de vacances à la fin août.

Aujourd'hui, je reçois votre lettre du 9 juillet et je ne vous cacherai pas que je suis fort désagréablement surpris par ce que vous m'apprenez à propos du Prof. J. Mehra. Quand, avec l'accord de Mr Besso, je lui avais laissé pendant quatre ou cinq jours la correspondance, il avait été bien précisé, de ma part comme de la sienne, que c'était seulement pour qu'il la lise, vu sa compétence et son intérêt - d'après ce qu'il m'a affirmé - pour tout ce qui concerne la théorie de la relativité. Il m'avait même promis de faire un compte rendu de mon livre dès qu'il sortirait. Il m'avait proposé de collaborer avec moi pour la partie scientifique : j'ai dit alors que Mme Tonnelat s'en était déjà chargée, comme il avait été convenu avec Mr Taton, mais que je lui serais reconnaissant de me dire quels passages scientifiques étaient, à son avis, les plus importants. Peu après sa visite, j'avais mis au courant MM Taton et Berès et aussi, en quelques mots, Mlle Dukas, car l'insistance manifestée par Mr Mehra à vouloir collaborer avait fini par m'étonner et même par m'agacer.

Or, d'après ce que vous me dites, Mr Mehra s'est permis de prendre de s copies (de toutes les lettres ou d'une partie ?) - et je puis affirmer sans aucune autorisation - et il s'en est même vanté auprès de Ronald W. Clark. De tels procédés sont pour le moinssurprenants de la part d'un scientifique et j'ai de la peine à en comprendre le mobile et le but. J'aimerais beaucoup connaître votre avis au sujet de cette affaire et quelle suite vous estimez qu'il convient de lui donner.

Thank you for your letter of July 8 and the copy of the letter of July 6 which you received from Professor Mehra. I share your view that the letter may not require a redy. Certainly not for the time being, as I shall want to explain.

Besides the letter to Mehra of June 29, of which I had sent you a copy, we had some other correspondence with him. You may have seen an announcement of the publication of a new biography of Einstein which was prepared by the English journalist Ronald W. Clark. In the notes of that volume it is stated that Mehra possesses copies of the correspondence between Einstein and his life-long friend Besso. He made those copies available to Clark. We were very distressed since Clark used passages from the Einstein letters which we would not have permitted him to do had we known about it in good time.

The question is how Mehra got possession of the copies. I have made enquiries, particularly of a professor in Geneva, Switzerland, who just completed the editorial work of the Einstein-Besso correspondence for publication by a French publishing house. Mehra called on that professor some time ago and was given access to the correspondence in question. The letters exchanged between Mehra and myself about the Einstein-Besso correspondence are attached, together with Mehra's and the "Center's" replies to my letters of June 29.

If I should want to reply to the Mehra letters at all I should certainly not do so before having received a reply from Geneva. This reply may throw some light on how Mehra was able to obtain copies of the Einstein letters.

May I suggest that you, too, postpone your decision about a reply to Mehra until the receipt of a reply from Geneva? I shall keep you informed.

Dear Dr. Nathan:

I have just now received another letter from you dated June 29.

Mr. Ronald Clark is a friend of mine. I consulted and cooperated with him in every way I could during the time he was working on his biography of Einstein. Mr. Clark visited me in Austin, and I have visited him in London, and we have discussed his work at great length.

I placed all the materials I have collected on Einstein over the years at Mr. Clark's disposal. I am quite sure that he recognizes, just as I do, that the literary rights to Einstein's writings are a property of the Estate. I also understand that he has received permission from the Estate to publish the materials contained in his book.

It is not quite clear to me what you mean by saying that I had no right to show him (such as copies of letters or other material) "without the permission of the Estate". Please be good enough to let me know whether the permission of the Estate is necessary for using the materials for publication or for possessing copies and showing them to interested scholars as well.

Again, let me point out that soon after I obtained copies of Einstein's letter to his uncle and his article, I presented you and the Estate copies of them. You or the Estate did not know about their existence, so far as I am aware. I thought I showed great courtesy to you in doing what I did. It is my feeling that your present letter and the one I have already answered do know show the same consideration towards me. I sincerely hope that you would extend to me the same courtesy in the field of Einstein scholarship as is available to others.

This is in response to your letter of June 29, 1971, concerning the article Albert Einstein's "First" Paper by Dr. Jagdish Mehra. This item is a preprint. It is not a published paper, nor is it part of a periodical or serial publication. It is neither available to the public, nor is it for sale.

Most of the research done at our Center, when completed, is first written up as a preprint. The date and the number on the pre-print are part of our filing system. We simply assign the document a number and put the date on which this number is assigned. The preprints are sent by our researchers to certain colleagues elsewhere, who might give their advice or comment on the work. This is a general practice in many research institutions nowadays. It is only when the author is completely satisfied with his work that he sends it to a journal for publication.

Dr. Mehra's preprint was assigned our filing number on January 8, 1971. A number of preprint copies were made available about a week later. Dr. Mehra sent a few copies to selected individuals for comments, in keeping with our practice, only after he had received permission from the Estate. We shall be pleased to insert a clearer note in the preprints that the Estate of Albert Einstein owns the literary rights to the Einstein materials.

In any case, please note again that our research items are only preprints, not for sale. We hope that this confirmation would clarify that there has been no irregularity, nor is any intended.

I am surprised at your letter of 29 June. The item which you have called a "pamphlet" published by the University of Texas is merely a pre-print of our Center. It is a research document of the Center, and bears the date on which a filing number was assigned to it.

Permission to publish was given to me in your letter of 12 January 1971. The pre-print was sent to a selected number of people for suggestions, as one would send something in a draft stage. You had also made your suggestions on the translation of the letter at that time. You were in fact the first person to whom I had sent the translations I had prepared. When the article was completed it still bore the date and the number it had been assigned earlier, and you also received a copy of that.

It is not clear to me how the permission, which had been sought and granted, to publish the material in a scholarly journal has been violated by the pre-print (which is not a publication).

Allow me to say that I have not violated any faith or courtesy in dealing with you. I gave you and Miss Dukas copies of these materials soon after I obtained them, already in spring last year. It is my impression that there might be people who wish to publish on Einstein themselves, and are seeking to interfere. May I request you, indeed urge you, to re-affirm the spirit of your letter of 12 January 1971. I shall be grateful for this.

I had received your letter, but my father's death and other personal misfortune did not allow me to write to you earlier.

I was pleased to learn from you that the papers which Miss Dukas had been missing were returned to her without loss.

The conclusion in the second paragraph of your letter is both unfair and unnecessary. During my visits to Princeton since 1958, I have called upon or telephoned Miss Dukas whenever I could. She has always been aware of my affectionate regard and respect for her, and she has always treated me as a good friend. I shall never do anything to hurt her or the obligations she is responsible for -- nor is it my custom to do so to other people.

Since I first met you in your office at Harvard before you went to the Institute, I have had the highest respect for you. You also allowed me the pleasure of visiting you in your office last year. If it is convenient to you, I shall be glad to call on you when I visit East Coast in the fall and explain to you every minute of my last visit to Princeton and the Institute.

I have been engaged on Einstein studies since 1952 when I first wrote an essay on his scientific work, and which he was kind enough to praise. Soon after I obtained copies of Einstein's letter to his uncle and an essay written by the young Einstein, I presented Miss Dukas, Dr. Nathan, and the Estate, copies of these materials. Following our phone conversation this morning, I called Mehra and told him that the missing documents had been received in the mail under the circumstances you described. Among other things, he asked that I verify this to him in writing and I told him I would, and have done so by my letter to him of even date, copy of which is enclosed.

He also requested that you so inform him, because I had only had the word from you over the telephone, or that you confirm it to me in writing and I could send him a copy of the letter. I told him I didn't see the need for this but would pass it along to you. I suggest that perhaps you write me essentially to the same effect as I wrote Mehra, identifying the documents in question as those shown on the list your secretary sent me April 15 and which she gave over the phone to my secretary also on April 15. I don't think it is necessary to say anything more than that the documents were received on April 20th under the circumstances you told me about and as I outlined in my letter of even date herewith to Mehra.

I think Mehra is fishing for something which will say "we know you didn't do it" or "we are sorry to have bothered you" or "we won't look into this any more", but I do not feel it is necessarily advisable to get into those matters in such a letter. If it meets with your approval, I will send a copy of your letter to me of the variety above suggested to Mehra, and I see nothing wrong with this.

We have recently learned that, under the date of January 8, 1971, you published a pamphlet by Jagdish Mehra entitled <u>Albert Einstein's "First" Paper</u> (CPT-82; AEC-31). It appears that the pamphlet is an issue in a periodical or serial publication. Since we have not been acquainted with it before, we should like you to advise us about the nature of the publication. We should also like to know at what price the individual issues are being offered to the public and what the approximate size of distribution of the publication is.

We were surprised to notice that there is nowhere in your publication an indication that the literary property in Professor Einstein's early paper and in the letter to his uncle is owned by this Estate. We had advised Professor Eehra in a letter of March 25, 1971 of the Estate's ownership in the Einstein material (although that should have been known to him anyhow); we added that we should like to have the ownership indicated in his publication. At that time we did not know that the material had been published 22 months before.

We should like to request herewith that all the Einstein material (including the photostate of Einstein's originals) be copyrighted in the name of the Estate and that you insert a copyright notation in all copies of the publication which you might distribute henceforth. We except a original for to the first.

Dear Dr. Kaysen:

I should like to thank you again for all the help and assistance you have given us, particularly in regard to that mystery story which, thanks to your investigations, seems to be less a mystery than it appeared in the beginning.

It is in regard to that problem that I should like to ask for additional advice. The gentleman in Austin informed us some time ago that he had been able to obtain copy of a letter which Einstein had addressed to one of his uncles in 1894 or 1895 and in which he had included what might be his very first paper on scientific matters. The gentleman offered to let us have Einstein's letter and paper but requested in return that we allow him to publish an English translation in an American scientific journal. We gave him permission "to publish Einstein's letter to his uncle and his paper on 'The State of Aether in Magnetic Fields' in an article on the origins of Special Relativity to be published in one of the scholarly journals." Since the reproduction of the German originals was never mentioned, we had no reason specifically to limit our permission to the publication of English translations (although it would have been wise to do so); our request that copy of the English translations was to be submitted to us before it was to be sent to the journal for publication indicated that it had never occurred to us that he might publish the German originals in photograph.

We have found out only recently that The Center for Particle Theory at the University of Texas has published a special pamphlet over the name of that gentleman including an article by himself, Einstein's letter to his uncle, Einstein's paper and a photostatic copy of Einstein's long hand originals of letter and paper.

The question is whether we should take any action, whether we should write him that he has violated the permission given him by the Estate and whether we should request of The Center for Particle Theory to discontinue the distribution of the pamphlet which they have published without permission of the copyright owners. We are unable to appreciate whether or not such action might help or possibly impair the steps which you have taken and which you might

It may be possible that one should leave things alone and not do anything except possibly advising him briefly that we well realize that he has acted without, and against, our permission in having the pamphlet produced by the Center. Memorandum for the Record

Re: Einstein Papers

At about 3:00 P.M. this afternoon Mr. M. C. Morgan, Jr. informed me that some material was missing from Miss Dukas's files. Miss Dukas came to my office and told me the following:

- 1. On Friday morning (April 9) she showed Dr. Sambursky various items--her card index and the like--and in particular she showed him the folder "Published Scientific Manuscripts 1914-24." This folder usually is the first one in the top drawer in the combination safe-file just inside the door of Miss Dukas's office. The first division of the first drawer holds an index and the file is the first of the group on the other side of the division. During the morning Miss Dukas is certain that she did not let the file out of her hand or physically give it to Professor Sambursky but merely showed him some of its contents. She remembers distinctly putting the file away.
- 2. Professor Mehra came in sometime after 2:00 P.M. and stayed for an hour or so. The safe was again opened. He was not shown documents from this file nor did he remain for any length of time in Miss Dukas's office. He worked for less than an hour in the outside office noting and copying some materials. During his conversation with Miss Dukas she reminded him that he had borrowed a reprint which he had promised to return and had not done so. Mr. Mehra left saying that he was going to a lecture in honor of Professor Rogers at the University.
- 3. Miss Dukas opened the safe again Monday after lunch with the notion of showing Mrs. Sher some of its contents. At that time she noticed that the folder was not in order. Examination showed that the attached items were missing.

SUBJECT: Missing Einstein papers, contacts with Jagdish Mehra

This is a narrative memorandum to informally memorialize some of the matters which came to my attention in connection with the Einstein papers which were missing from The Institute For Advanced Study for approximately 18 days in April 1971, and my contacts in regard thereto with one Jagdish Mehra. This memorandum is prepared May 4 and 5, 1971 while most of these events are fresh in my mind, and in preparing it I have relied not only on my memory but also on certain notes made by me and letters written, as well as those received, during this time to refresh my recollection. This memorandum, however, does not purport to be a 100% complete recitation of everything that I remember in respect to the events here discussed.

On Wednesday, April 14th, in the early afternoon I believe, I received a call from attorney Reeves Hicks, in Princeton, inquiring whether we would be available to be retained as counsel to assist in locating some missing documents for an unnamed client of his as to which it was thought an individual in Austin might have some connection. I indicated we would and he called me back in a few hours later and said that the clients were The Institute For Advanced Study which acted as custodian of many of the papers of Dr. Einstein, and the owner of the papers, the trustees of Dr. Einstein's estate, Dr. Nathan and Miss Dukas; our retention as counsel for these clients was confirmed and Hicks explained that the missing papers were some of those of Dr. Einstein, and that the individual in Austin whom it was thought might have some connection

with or knowledge of these papers was one Mehra. Hicks went on to say that the papers were kept in a vault in a lower floor at the Institute For Advanced Study, next to which was a copying room, and the interested persons sometimes came to examine the papers. Miss Dukas was customarily on duty in the vault where the papers were, and there was also usually an employee in the adjacent copying It was thought that the papers became missing, Hicks said, on Friday, April 9th, inasmuch as Miss Dukas remembered seeing them that morning when she held the folder in which they were in her hands and was showing the papers in it to an interested person (a man whose name Hicks mentioned but which I have forgotten), Miss Dukas further recalling that on this occasion the papers remained in the folder in her hands, and that when the man she was showing them to left she put them back in the lockable file cabinet in which they were usually kept. Miss Dukas recalled that in the early afternoon of the same day Mehra came by and looked at some papers (Miss Dukas not recalling that they were specifically the papers which were later missing) and was also in the copy room and she mentioned something to him about his not having returned some other papers he had previously borrowed. Apparently very shortly thereafter he became somewhat agitated and left saying he didn't feel well, or something to that effect, and that he was going to some character of function being held elsewhere around Princeton. As I understood it, the vault and copy room closed for the weekend at the end of the working day on Friday, April 9th, and did not reopen until the following Monday, April 12th. Monday morning, April 12th, Miss Dukas noticed that the papers in question were missing. missing papers were identified as originals of published manuscripts during the period 1914 to 1924, being Nos. 1 through 15 (including 3A), 20 and 21 in a folder containing Nos. 1 through 24; I did not get the exact titles; the papers did not have any particular scientific value as such, inasmuch as they had all been published or copies of them made available elsewhere, but being originals they likely had very considerable value as collector's items or museum pieces. It was explained that after the documents were discovered missing on Monday morning, April 12th, a very thorough search was made for them everywhere, and Dr. Kaysen, the Director of the Institute was consulted, and finally being unable to locate the papers anywhere, Mr. Hicks, who was an attorney for the Institute was consulted and he determined to call me.

Hicks stated that since Mehra was present at the Institute, and in the vault in question, on the day which the evidence indicated that the documents became missing, it was therefore thought to be at least very possible that he had them; that they were checking with all others who had been there that day, and it was not entirely clear to me whether there was only one other person than Mehra, that previously mentioned to whom Miss Dukas recalled

showing the documents in the folder, or whether there were more than just two outsiders in the vault that day, but in any event it was clear that if there were more than two there were still only a very few; Hicks moreover stated that Mehra, an Indian (from India) who was a professor of some sort in the Department of History of Science and/or physics at the University of Texas, had a somewhat shady reputation in the academic community in the sense of overstating his credentials or his work or things of that nature, but not necessarily a reputation for actually stealing anything, and that the said other "outside" person whom Miss Dukas mentioned had an excellent reputation. Hicks pointed out that it was possible that the papers were taken either intentionally or by accident, as if someone had picked them up with their own papers and walked out not realizing that they had them.

We decided I would approach Professor Mehra directly, telling him I had been retained by The Institute For Advanced Study and the trustees as an attorney to assist them in the recovery of the documents, explaining the situation to him with reference to when it was thought the documents became missing and how the Institute desired to check with whoever was there that day on the thought that they might possibly have the documents or might have picked them up along with their other papers, and requesting that they search their files to see whether they had them.

After talking with Hicks on this second occasion, I looked at the staff and faculty directory at the University of Texas 1970-71 and could find no J. or Jagdish Mehra listed, although I did find a Mrs. Marlis Mehra listed as a teaching assistant in Germanic Languages and showing a home address at 7606 Rustling Road, which the phone book showed to be that of Jagdish Mehra.

I then tried to call Mehra in the late afternoon (about 6-6:30) at his home address, but got no answer. Later, about 7 or 7:30 p.m., April 14, I called his home again and reached him. I told him my name, that I was an attorney who had been retained by The Institute For Advanced Study and wanted to talk to him on their behalf about something. He asked me what and I said I preferred not to go into it until I could personally meet with him and talk about it. He pressed me several times but I maintained this position. I asked him if he was in the department of History of Science at the University of Texas, but he said there was no such, and that he was connected with the UT Physics department. I offered to meet him at his office the next day. He said he was perfectly willing to see me right away and I could come out to his house that night. I said I would be willing to this, but if he preferred I would also be perfectly willing to see him at his office the

next day. He indicated a preference that I come out to his house that night, so I told him I would and after dinner I went out to his house arriving at about 8:30 or quarter of nine.

His house is in a new development in a nice section of town and appears to be worth in the neighborhood of \$30,000 to \$40,000, perhaps in the lower ranges of those figures (whether this is rented or owned I don't know). When I got there Mehra was standing in the front lawn. He asked me in and we went into his living room to talk. The house was moderately furnished, and seemed reasonably clean and orderly.

I gave Mehra one of my professional cards, and again explained that I was an attorney and had been retained by The Institute For Advanced Study. Then I directly went into the matter of the missing papers, how they were thought to have become missing on April 9th, how it was understood that he was there at that time and how they therefore desired that he check over his papers, etc. to see if he did not have these, also stating that similar checks were, as I understood it, being made with whoever else was there that day. Mehra asked me directly whether he was being charged with stealing the documents. I said that so far as I knew no one was being charged with anything but the Institute simply desired to get the documents back and wondered if he had them on account of the circumstances above mentioned. He said of course he did not take the documents and that furthermore he was not even at the Institute anywhere near April 9th.

He then proceeded to explain that he had left the Princeton area days before April 9th and could conclusively prove this; that he arrived in Princeton (or the vicinity) in the late afternoon or evening of March 31st after having been at Yale, that on April 1st he had been at the Institute and seen Miss Dukas from about 3 to 3:20 in the afternoon, and that he had been around the Princeton area on April 2nd or 3rd, but had not actually been at the Institute on those days, and that he left to return to Austin from Kennedy Airport on April 4th. I was pulling out my calendar and trying to follow the days of the week for the dates he mentioned, and I said to him that March 31 was a Wednesday and as I understood him he was at the Institute on Thursday, April 1st but not on Friday or Saturday April 2nd or 3rd; however, while Mehra indicated agreement to this, he did not have a calendar with him (though he briefly looked over his shoulder at mine) or his diary or anything of that sort (though I understood his diary was close at hand) and he was talking very rapidly, and my attention was directed to the fact that this was considerably removed from April 9th, the crucial date, and I did not press for an unequivocal assertion from him

that he was sure he was not at the Institute April 2nd. I explained to Mehra that there must be some mistake, but I did not know quite what it was.

Mehra in the course of our conversation also mentioned that he had an Einstein reprint of some kind which he took me into his study to show me, which he had gotten from the Institute For Advanced Study and which he had not returned as soon as he indicated he would, and he said that when I called him he thought that Miss Dukas had been complaining about this and was trying to get me to get this reprint back from him. He offered to give it to me so that I could send it back, but I declined, pointing out that this was not my mission and that I was only concerned with the missing documents in the 1914 to 24 period as I had explained to him. He said he had recently, either April 12 or 13, gotten a letter from Miss Dukas about the reprint, and I also believe he said she had called or wired him about it recently, but I am not sure about the call or wire.

Mehra said he had a great many papers related to Einstein in his study and that he was an Einstein scholar and his name was always connected with Einstein's; also that he usually locked his study because sometimes his son would get in there and might mess things up or something of that nature.

I saw no evidence of either his son or his wife anywhere around the premises, nor was there any particular indication that they had been there recently. In the course of our conversation he also mentioned that he had a severe migraine headache that day and he was subject to migraine, that tobacco smoke in a small room was hard on him, and also that he was subject to claustrophobia and that when he had last been up at the Institute and down in the vault he had had something of an attack of claustrophobia and had to leave rapidly for that reason.

I explained to Mehra on this occasion that the missing documents were numbers I through 15, including No. 3A, and Nos. 20 and 21 out of a file which ran from No. 1 through 24; that they were originals of various published manuscripts of Einstein's during the 1914-24 period. Mehra asked me several questions about the value of the documents, and I explained I understood they did not have original scientific value any more, as they had been published or otherwise reproduced, but that they did have potentially a fairly large value as collector's items or museum pieces. Mehra was interested in knowing whether the Institute knew exactly what documents were missing, as early in our conference (before I was taken in his study) I had said I was unable to say just exactly

what they were, and I assured him that the Institute did know exactly what documents were missing, because they had a list of them by title and that the numbers on the documents were keyed to these titles so they knew exactly what it was that was missing.

Mehra said something to the effect that he supposed the Institute was very desirous to avoid any publicity about this, and I indicated that that was partially the case, although it would have to become at least semi-public knowledge and they would notify people if the documents were not found in the near future, probably notifying collectors, museums and other places the documents might show up, and also the authorities.

Mehra was also somewhat concerned as to really who I was, and so finally to satisfy him about this, we called Hicks, reaching him at his home at probably around 9:30 or so that evening. I talked to Hicks in Mehra's presence relating essentially what had transpired from our visit to that point, particularly that Mehra had not been at the Institute on April 9th or for several days prior thereto, and when I got through talking to Hicks, then Mehra proceeded to talk to him on the phone in my presence. I cannot remember anything of these phone conversations which was not essentially duplicative of what I had already talked to Mehra about.

Mehra also said on this occasion that he knew Miss Dukas very well and thought very highly of her, was sure that she was very disturbed about the papers being missing and that he was very anxious that they be found so that she would not be further upset and the like, and he also mentioned knowing Dr. Kaysen and being surprised that Dr. Kaysen or Miss Dukas didn't contact him directly, but had instead chosen to contact him through me, an attorney.

Mehra was rather upset during the whole conference, was very talkative, and displayed a rather strange and varying mixture of defensiveness and aggressiveness.

Because Mehra had not been near the Institute on or about April 9, we did not come to any very clear conclusion at our conference, but I indicated to Mehra there was likely some mistake in dates and I would find out and likely be in touch with him; he rather vaguely indicated he would look in his papers anyway.

The next day, April 15th, Thursday, I did not contact Mehra. I tried to call him but did not reach him (I think I tried once at his home and he was not there, and I cannot now remember whether someone was there and gave me his number at the University and I called there and was unable to contact him).

Mehra can be reached at the University of Texas through the Physics Department, but I have never found out just precisely what his status or position there is or was at the time.

Sometime on April 15th Dr. Kaysen called me from Princeton and I related to him briefly the upshot of my visit with Mehra and how he had not been there on April 9th or anywhere near then, and Dr. Kaysen informed me that April 9th was a mistake and that actually it was April 2nd, likewise a Friday, that the papers were thought to have first become missing, and that all the events previously attributed to April 9th occurred on April 2nd and likewise that the initial discovery that the documents were not there took place on April 5th, Monday, rather than the following Monday, April 12th, etc. Dr. Kaysen said his secretary would phone into my secretary a list of the titles of each of the documents. In this conversation it was also determined that I would again contact Mehra, tell him my mistake, that the day was April 2nd, and that I wanted to know for sure whether or not he was there April 2nd and wanted him to look over his papers, etc. to be sure that he did not have these documents, as perhaps the information concerning April 9th had caused him not to make the search previously requested. A little bit later on April 15 Dr. Kaysen's secretary called and gave my secretary over the telephone a list of all the documents, which she typed up.

April 16, I wrote Mehra a letter dated April 16th, with a copy of the list attached, and a copy of such letter and list are attached hereto. However, after I had dictated this letter and before I had mailed it I got in touch with Mehra over the phone. I recall, he called me. I gave him the information which Dr. Kaysen had given me, namely that the date was April 2nd, and I also told him that I had gotten a list over the phone of the documents and that I would send these to him with a cover letter. He stated that he was coming by The Austin National Bank, in which building my office is located, and that he would just drop by and pick up the letter and list. I made it quite clear to him in this phone conversation that I wanted to know whether he was there April 2nd. At this time he said of course he did not have his diary with him and he couldn't say, taking a good deal more of an attitude of precision about this than he had previously, and he also stated that he had not searched his documents, and that he would do so but that it might take some time as he had a lot of them.

During this phone conversation on April 16, and again when he came by my office later that day, he mentioned to me, and I believe he had also mentioned it to me when I was at his house on the evening of April 14th, that he had never really had any contact with an attorney before, but that since I was an attorney and he had now come into contact with me he was wondering if maybe

I couldn't do a will or some other similar matters for him that he had need of. The impression I got, frankly, was that he wanted to retain me so that I would be representing him and thus in a sense would be disqualified to do anything against him. I kept putting him off.

About 4 p.m. April 16th Mehra came by my office and I handed him the letter to him of April 16th and the copy of the list of the documents my secretary had typed up pursuant to the call from Dr. Kaysen's secretary. He was not in my office more than 15 minutes.

Another thing that Mehra said either during the meeting in my office on April 16th or earlier that day on the telephone was that he wondered whether The Institute For Advanced Study was going to the authorities and whether there was going to be any criminal prosecution in case they got the documents back, and I stated that I really didn't know and that they had not indicated to me that there was going to be any criminal prosecution but that I was only interested in trying to get the documents back.

Also on April 16th (in the phone conversation or office visit or both), and also possibly on April 14th but I am not sure about April 14, Mehra asked me more than once whether he should get an attorney, and I told him in essence that I would never advise anyone not to get an attorney, that some people in his position would get an attorney and that some people would not, and that if he was concerned about the matter then quite possibly he ought to get an attorney. He said that he was not concerned about it but still wanted to know from me whether he should get an attorney, and I would again repeat what I had said previously.

I made it quite clear to Mehra on April 16th that I did want to know whether he had been there on April 2nd, which I made sure he understood was the crucial date, and that I did want him to check his documents for the missing papers.

On April 17th I received a letter from Dr. Kaysen's secretary dated April 15th with a list of the missing documents; likewise on April 17th I made a Xerox copy of this letter and list and sent both to Mehra with my letter dated April 17th (copy of my letter of April 17 to Mehra attached). The afternoon of April 17th I went to Houston and returned to Austin late in the morning of April 18th and on neither day did I have any personal or telephone contact with Mehra.

On Monday, April 19, I received in the mail from Reeves Hicks, without a cover letter, a copy of Dr. Kaysen's April 13, 1971 "Memorandum for the Record" and of the list attached thereto.

On Monday, April 19th, Mehra called me. He asked whether the folder in which the documents were was missing and I said I didn't think so. I thought I had already told him that, but I am He stated that he had not yet examined his papers, that they were too numerous but that he would do so. He asked me very pointedly about how many people were there, how many outsiders, on April 2nd, and this was also something he had asked me two or three times before, and I told him I really wasn't sure, that I had only been told one other name of anyone who was there, and that I couldn't remember what that other name was. As I recall this telephone conversation was relatively early in the morning something like 9 or 9:30; I am sure it was in the morning but it might have been later in the morning. In this phone conversation on April 19 Mehra did definitely say that he was at the Institute on April 2nd, and he also acknowledged receiving my letter to him of April 17th and its enclosed list and copy of letter from Dr. Kaysen's secretary.

On April 20th, in the morning, I received a call from Dr. Kaysen who informed me that the missing documents had been received earlier that morning (April 20) in the mail in an envelope, or, more accurately speaking, wrapped in paper, the postmark thereon indicating it was mailed on April 19th in Newark, New Jersey, the circumstances as related to me by Dr. Kaysen in this regard being more particularly set out in my letter of April 20th to Mehra (copy attached). Within approximately an hour at the most after my phone conversation with Dr. Kaysen on the morning of April 20th, I called Mehra on the phone and told him that the documents had been received in the mail at The Institute For Advanced Study that morning, namely April 20th, and told him the circumstances (i.e., those stated in my letter to him of April 20th). Mehra indicated that, in view of the documents having been recovered, he would like to have a letter from me; I did not exactly understand what he meant, but he seemed to be indicating (without coming right out and saying it) that he wanted some kind of an apology or something of that nature, while at the same time saying he wanted something in writing to the effect that the documents had been recovered. I told him I would be glad to relay to him in writing what I had just told him on the phone as to the return of the documents. I proceeded to do so and wrote him on April 20th by the above mentioned letter.

In the course of our phone conversation on April 20th Mehra mentioned something to the effect that he had seen an attorney; in view of this I asked him whether he wanted me to send the letter in question to his attorney, rather than to him; he then very quickly said he had not actually retained an attorney, he had just opened up with an attorney the question of whether he might retain him, but Mehra was very definite that he had not retained him, and likewise was very definite that he wanted the letter from me to be sent to him, not to the attorney; he did not mention who the attorney was.

In this April 20 phone conversation Mehra also stated that he wanted some character of letter from Dr. Kaysen. I said I didn't quite see what the point of this was inasmuch as he was going to have a letter from me, but he indicated that I had only heard over the telephone that the documents were returned, and he would like something from Dr. Kaysen who presumably had actually seen them, and at the same time he continued to hint for some sort of letter of apology, or some kind of a letter that would get him off the hook, but he never did come out and expressly put it this way. I merely told him I would forward this request on to Dr. Kaysen, indicating that I would do so merely in terms of mentioning to Dr. Kaysen that Mehra wanted a letter that said that the documents had been recovered.

In this April 20 phone conversation Mehra also said something to the effect that he presumed this would be the end of the matter since the documents were recovered. I did not state anything in reply to this other than I did not know what plans the Institute had, but I knew they were glad to have the documents back and that the circumstances under which they were received were unexplained and mysterious. In our April 20 phone conversation Mehra also asked something about whether the Institute had gotten the folder back. I told him the folder had never been missing, as I had told him previously.

I have not heard from Mehra one way or the other since April 20th, nor have I made any attempt to contact him other than writing him the letter dated April 20th. On May 1st I received Dr. Kaysen's letter to me dated April 29th and a copy of his letter of the same date, enclosed therewith, to Mehra.

The only occasions I have seen Mehra in person are the evening of April 14 at his house and the afternoon of April 16 at my office. The only other contact I have had with him are phone conversations on April 14, 16, 19 and 20, and my letters to him (and their indicated enclosures) of April 16 (delivered to him in my office), 17 and 20.
